The residences include one and two bedroom apartments ranging in size from approximately 800 SF to over 1,300 SF. The Assisted Living neighborhood provides studio and one-bedroom accommodations for residents and include a dining room, activity rooms, library, crafts room, and a small home theater. One large home, designed to accommodate approximately 36 residents, houses the program for residents requiring Memory Care.
